Budget (PH) - 2021 SPECIAL DISTRICTS BUDGET for the TOWN OF CLAY:

Supervisor Ulatowski explained that he would open all of the budget hearings together and that John Shehadi, the Town Comptroller would give an overview of the various budgets for 2021.

Mr. Shehadi explained all of the budgets and gave a power point presentation(see attached) of each budget broken down.

Mr. Shehadi surmised that residents will see no increase in their Town taxes, no decrease in town services due to securing grant monies for many projects (see 2021 Budget Message, attached).

Cheryl Iorio asked about the solar panels and if the Town has seen a significant savings since their installation. Supervisor Ulatowski said about 1/3 less for the Town Hall and about 1/2 less for the Highway Garage.

All questions having been heard, Supervisor Ulatowski closed the public hearings.

A public hearing to consider the amendment of CHAPTER 211, entitled TRAFFIC AND VEHICLES ORDINANCE of the Code of the Town of Clay, SECTION 211-12 "STOP INTERSECTIONS," SCHEDULE IX (§211-42), of the Town of Clay Municipal Code to designate and provide for nine (9) stop signs to be installed at the intersections of Fuchsia Path at Johanna Drive, Silvia Path at Justin Drive and Johanna Drive at Justin Drive in Sections H & I of the Country Meadow Subdivision to make three-way stops; and the installation of the necessary signs therefore was opened by the Supervisor; proof of publication and posting was furnished by the Town Clerk.

Release of Securities (\$25,000.00) - VIP True North, LLC.:
