## <u>Traffic & vehicles (CPH) Amendment to Traffic & Vehicle Ordinance</u> <u>Chapter 211 Sections 211-30, 211-30B, 211-31 and 211-32:</u>

Councilor Edick moved the adoption of a resolution calling a public hearing **December 16, 2013** at **7:35 P.M.**, local time, at which time the Town Board will consider the amendment of **CHAPTER 211, TRAFFIC and VEHICLES ORDINANCE** of the Code of the Town of Clay, **SECTION 211-30 "AUTHORITY TO IMPOUND VEHICLES,"** by deleting the words "under the direction of the Commissioner of Public Safety," and replacing with "under the direction of the Commissioner of Planning and Development or the Town Constable" and further adding to **SECTION 211-30B** "where said vehicle constitutes an obstruction to traffic" or "obstructs a fire hydrant, driveway or residential mailbox" to the Town Code of the Town of Clay. This ordinance will also amend **SECTION 211-31** "**STORAGE and CHARGES"** and **SECTION 211-32 "NOTICE OF REMOVAL"** by deleting "Department of Public Safety" and replacing with "Department of Planning and Development" to the Town of Clay Municipal Code; and to designate and provide for the installation of necessary "**TOW AWAY**" signs therefore within the Town of Clay. Motion was seconded by Councilor Bray.
